

You have agreed to assist the French National Cancer Institute [henceforth, National Cancer Institute or INCa] in the fulfilment of its public service mission.

Out of respect for the general public and all of the professionals working alongside it, the National Cancer Institute is mindful of its impartiality and its independence of opinion. With this in mind, it is one of the institute's duties to manage conflicts of interest in order to protect the credibility of experts, the public's trust in science and the scientific community and personal and institutional reputations. Transparency by all those involved is essential for accomplishing our public service mission in its entirety.

All experts must, prior to starting their mission, declare any connections they have that may cause a conflict of interests (e.g. the sale of company shares, abandonment of certain professional projects in competition).

The form below must be used in this process.

The type of connections suggested relates to the most common situations and pick up on a number of objective and concrete criteria. Due to the specific nature of some situations, you must ensure that you examine and indicate if any other connections, past, present or future, may bias your judgment or give rise to suspicion of a conflict of interests between your assignments at the institute and your external activities.

Finally, over the course of your mission, it is your duty to withhold a judgment or refuse to participate in a decision if you reasonably consider that you cannot review the matter impartially or if you fear that your impartiality may be called into question.

Your declaration must be exhaustive, completed before any involvement in the work of the institute and must be updated at least once a year or whenever a change is made to the connections declared or a new conflict of interest arises. Failure to provide updates may lead to suspension of the assignment.

The method for evaluating the declarations and management of conflicts of interest is described in a document available on the National Cancer Institute website.

The information gathered below will be reproduced electronically and your declaration (apart from your contact details and information relating to your family members) will be published on the INCa website. In accordance with the French Data Protection Law No. 78-17 of 6 January 1978, modified in 2004, you have the right to access, correct and remove data relating to you held by INCa. You do have a right to oppose publication of your personal data only for legitimate reasons. 
